Rider Membership Rules

1. **All riders must have a current AEF membership or other event insurance that adequately covers the rider for any injury or death.**
2. Membership is for **PERSONAL HORSES ONLY**, those riding other horses must pay either a drop in fee per time, purchase a membership for outside horses or purchase a trainers membership.
3. Key fob access is for your personal membership only. If arena is open, please still scan your fob.
4. The WDAS has the right to revoke this membership as seen necessary.
5. It is recommended by WDAS that all horse riders wear a helmet specifically designed for horse riding.
6. Arenas are available for riding from 9 am until 9 pm.
7. If you wish to book the arena for a private event a Rental Agreement is available online.
8. Membership fees must be paid before member will be given access to the arena. From time to time this code will be changed and member will be contacted by email with the new code. Please keep these codes confidential.
9. If you are bringing a guest rider to the facility to ride it is your responsibility to ensure they sign a waiver, have a current AEF membership and pay the applicable drop in fee. The forms are available in the indoor arena and money can be placed in the drop box or emailed to wctagsoc@gmail.com with the completed forms.
10. Indoor arena members are welcome to use the indoor arenas, outdoor arenas and WDAS grounds for riding.
11. No WDAS equipment will be used without approval from WDAS.
12. Members and day pass holders will conduct themselves in a cooperative manner to allow for the multidiscipline activities at all WDAS facilities while being respectful of other riders and mindful of everyone's safety. Refer conflicts to the Board via email wctagsoc@gmail.com
13. Clean up after yourself and your horse. Pick up manure and litter around your trailer, in the arenas and on the grounds. A minimum of \$100.00 may be charged to the individual or group if cleanup is not completed adequately.
14. No smoking in or near any WDAS buildings.
15. No alcohol is permitted on the grounds unless prior approval and permits are obtained.
16. Should a member or day pass holder have an accident or near miss they must complete an Incident/Accident Report (provided in the arena drop box) and return to the WDAS within 24 hours. All accidents must be reported.
17. WDAS staff/board have the right to ask any person to leave the premises if they do not follow the above rules of if they become disruptive or abusive.
